

**Notice Informing Individuals About Nondiscrimination and Accessibility
Requirements and Sample Nondiscrimination Statement:
Discrimination is Against the Law**

1. Eye Surgeons of Indiana complies with applicable Federal civil rights laws and does not discriminate on the basis of race, color, national origin, age, disability, or sex. You can file a grievance in person or by mail, fax, or email. If you need help filing a grievance, the Operations Manager is available to help you.
